# 8/060521 To discuss the current status of the speed warning device and the County's proposal to deploy Automatic Number Plate Recognition devices on a trial basis

The ANPR pilot scheme in the County is relatively minor and will not result in prosecutions. The battery on the SID is worn out and cannot immediately be replaced by the German supplier because of Brexit difficulties. An alternative solution is being sought. It was agreed to spend up to £100 on a pop-up PC to deter speeders.

### 9/060521 To consider a report on the Village Hall and play area

Work is ready to begin on the new play area and many congratulations were offered to Kirsty Pollintine and her team on raising the necessary funds at a very difficult time.

The Village Hall has not yet fully re-opened and indications are awaited as to the likely level of demand.

It was agreed after discussion to make an annual contribution of £750.00 towards upkeep of the churchyard.
